DE stated the Commissioners have an Ordinance for the Dissolution of the Solid Waste, and he feels the Council should also approve that Ordinance. The Council would be reaffirming the Commissioner's Ordinance. KH feels the Council should have a copy of the Ordinance. The Council would be supporting the Ordinance.

SG made a motion to support the Commissioner's Ordinance, with no second. Motion died.

 b) Reminder of Open Board Appointments-Internal and External DE stated that if any Council member is interested in an Internal Appointment or if they know of anyone who might be a good member for the external boards, encourage them to apply. Letters of Interest are due on December 27, 2024 at 4:00 p.m.

Kelli mentioned that Courthouse Security will need internal appointments, with one being a Commissioner and the other a Council member.

c) A Special Meeting will be on December 30, 2024 at 9:30 a.m. and the 2025 Organizational Meeting is Thursday, January 2, 2025 at 4:00 p.m. at the Courthouse Meeting Room.
