The Perry County Council met on the above date at 5:00 p.m. as was duly advertised. Council members in attendance were Keith Huck (KH), Stan Goffinet (SG), Kelli Harding (Kelli), Earla Williams (EW), and Gale Garner (GG). Paul Malone was live streamed with Google Meet, but due to technical difficulties, he could be heard but was not able to be seen for a portion of the meeting. Auditor Kristinia Hammack and Attorney Rod Acchiardo were also present. There was no *Sheriff* or *News Representative* present.

The meeting opened with the Pledge of Allegiance.

## <u>COUNTY COUNCIL</u>

- a) Ordinance to Encumber funds from 2023
  - Auditor Hammack stated there were two requests to encumber funds from the 2023 budget over to 2024.
    - Request was received from Perry County Memorial Hospital out of Public Safety for the Ambulance Lease in the amount of \$50,000 in 2023. Hammack stated the County does have a contract with Perry County Memorial Hospital to supply equipment. They will be purchasing an ambulance in 2024, so they were wanting to encumber these funds.
  - SG made a motion to approve, seconded by GG. Motion carried 6-0.
    - 2. Request was received from Parks and Recreation for equipment repair. There are repairs in process for the Parks and Recreation vehicle, and there is a \$1000 deductible. An actual invoice has not yet been received, but the County knows they will be receiving this bill and paying in 2024. Kelli asked Hammack that she does not have an invoice, but did she have an email from the insurance saying the bill is coming, and Hammack confirmed this.
      - EW made a motion to approve, seconded by SG. Motion carried 6-0.
- b) KH stated this was Junie Voges' last day of work before retirement, and he thanked him for his service to the County and community.
- c) The next meeting is scheduled for January 2, 2024 at 5:00 p.m.
- d) Kelli stated that if anyone is interested in the open board appointments, they are listed on the Perry County Government website. Letters of interest must be submitted and received by the Auditor by 4:00 p.m. Friday, December 29, 2023.
