

**PERRY COUNTY COUNCIL
SPECIAL MEETING MINUTES
October 15, 2025**

The Perry County Council met on the above date at 11:00 a.m. as was duly advertised. Council members in attendance were President Kelli Harding (Kelli), David Etienne (DE), Stan Goffinet (SG), Cory Filley (CF), Brad Harth (BH), and Paul Brockman (PB). Auditor Kristinia Hammack was also present. There was no *Sheriff, Attorney or News Representative* present.
