

**PERRY COUNTY COUNCIL  
MINUTES – December 12, 2017**

The Perry County Council met on the above date at 4:30 p.m. as was duly advertised. County Council members in attendance were: President Steve Goodson, Danny Bolin, JR Flynn, Tom Hauser, David Etienne, Jody French and John Taylor. A media representative from the Perry County News and Council Attorney, Jim Tyler, were also present.

The meeting opened with the Pledge of Allegiance.

**ADDITIONAL APPROPRIATIONS**

The Perry County Commissioners requested additional appropriations for Health Insurance in the amount of \$100,000.00 from the Rainy Day Fund. Steve made the comment saying that we all know what is going on with the current insurance. Larry James, President of Commissioners, spoke up saying that we hope not to use all this funding. J.R. commented saying he was glad we were changing insurance companies for next year. Danny made the motion to approve the request, seconded by J.R. Motion carried 7-0. They also requested \$225,000.00 from the CEDIT Fund for Health Insurance. Jody made the motion to approve the request, seconded by John. Motion carried 7-0. Then there was discussion as to which fund to use first. It was commented that once Rainy Day is gone it is gone but CEDIT wasn't set up to use for Health Insurance. The Council agreed that they would like to see the Commissioners use the Rainy Day fund first.
