# PERRY COUNTY COUNCIL SPECIAL MEETING MINUTES October 12, 2023

The Perry County Council met on the above date at 5:00 p.m. as was duly advertised. Council members in attendance were President David Etienne (DE), Keith Huck (KH), Earla Williams (EW), Paul Malone (PM), Stan Goffinet (SG), Kelli Harding (Kelli) and Gale Garner (GG). Sheriff Alan Malone, and Auditor Kristinia Hammack were also present. There was no *Attorney* or *News Representative* present.

The meeting opened with the Pledge of Allegiance.

DE stated the purpose of the meeting was to adopt the budget. There were a couple of changes.

# 1. SAPS

At the last budget workshop, the Council was speaking with Judge Lucy Goffinet and she was helping to elevate the budget with her SAPS fund. A change was made in General and failed to go back and change SAPS. This amount was \$690.00.

KH made a motion to approve, seconded by PM. Motion carried 6-1.

# 2. Health Department

The amount that was requested was more than was advertised to the DLGF (Department for Local Government Finance) on September 1<sup>st</sup> by \$4,727. DE stated this can be corrected by moving funds within the categories or submit the salary increase by an additional appropriation made the first of the year. He believes there is a possibility to move within the group insurance. Auditor Hammack stated the Group Insurance as it stands now is over budgeted. Decreasing this by \$5,000 is a possibility, and should someone have a life changing event, it could be addressed later.

DE asked if retirement included Dr. Marcum, Health Officer, and Tara Lucus, Health Nurse Supervisor stated he does not get retirement.

PM made a motion to cut Health Insurance by \$5,000, seconded by KH. Motion carried 4-3.

3. Highway

The amount that was requested was more than was advertised to the DLGF on September  $1^{st}$  by \$26,630. Steve Howell, Highway Superintendent, requested to decrease New Equipment from \$50,000 to \$23,000. DE verified with Howell that was his intention to reduce this, and he verified.

KH made a motion to accept, seconded by GG. Motion carried 6-1.

DE then read the dollar amounts and tax rates as follows:

KH made a motion to accept, seconded by EW. Motion carried 7-0.

### **Solid Waste Ordinance**

DE had a question on the financial statement and proposed tax rate. He asked if the Miscellaneous Revenue for period July 1, 2023 is correct, as it is only \$40,000. He stated that amount is 1/12 of what the whole year is for 2024. Kris Wheeler, Perry County Recycling Management Director, responded this is miscellaneous revenue for tags, scrap cans, cardboard, and plastic. She further stated the \$481,000 is for the annual amounts of \$45.00 which are due in March. DE asked if revenue was dropping? Wheeler confirmed that this is due to the price of cardboard and plastic have gone down. Plastic is currently one-half of what it was.

DE stated the cash balance is misleading. He is concerned due to the beginning of the year it was \$230,000 and projecting next year to only have \$137,000, so they will be operating at a loss. Wheeler hopes the prices will increase; therefore, the figures will be better than projected.

DE asked if the Solid Waste Board had approved this budget, and Wheeler stated the budget was presented to the board, however they never voted on the it. Auditor Hammack stated this budget should have been approved by their board prior to submitting it in Gateway by September 1.

KH made a motion to approve the budget as it is, seconded by PM. Motion failed 3-4.

The Solid Waste Board will schedule a special meeting at 4:00 p.m. CST Tuesday, October 17<sup>th</sup> to get budget approved; the Council will hold a special meeting at 5:00 p.m. CST Tuesday, October 17<sup>th</sup> to approve the Solid Waste Ordinance.

The meeting was adjourned at 5:36 p.m. CST. KH made a motion to adjourn, seconded by EW. Motion carried 7-0.
