AN ORDINANCE OF THE  
PERRY COUNTY COUNCIL

APPROVING RECORDER'S REQUEST TO USE MONIES FROM THE RECORDER'S  
RECORDS PERPETUATION FUND TO PAY THE RECORDER'S OFFICE SUPPLIES,  
AND OTHER SERVICES AND CHARGES

**WHEREAS**, pursuant to Indiana Code 36-2-7-10.2(1), the Perry County Recorder submitted her sworn statement requesting to pay the Recorder's Office Supplies, and Other Services and Charges from the Recorder's Records Perpetuation Fund, for the calendar year **2025** and

**WHEREAS**, a copy of the Recorder's sworn statement is attached hereto and made a part hereof; and


**WHEREAS**, pursuant to Indiana Code 36-2-7-10.2(c), upon receiving the Recorder's sworn statement, the County Council may adopt an ordinance approving the Recorder's request, and

**WHEREAS**, the County Council wishes to grant the Recorder's request.

**NOW, THEREFORE BE IT ORDAINED AS FOLLOWS:**

The County Council hereby grants the Perry County Recorder's request to pay for Office Supplies, and Other Services and Charges in the amount of \$5,025 from the Recorder's Perpetuation fund.





## SWORN STATEMENT BY PERRY COUNTY RECORDER

Jane James, duly elected Perry County Recorder, submits her sworn statement to the County Council pursuant to Indiana Code 36-2-7-10.2(1) in order that the County Recorder may pay a portion of the expenses of the County Recorder's office for the calendar year 2024 from the Recorder's Records Perpetuation Fund (1189) established under Indiana Code 36-2-7-10(f) as follows:

1. Among my duties as the elected Recorder of Perry County, Indiana, I administer the Perry County Recorder's Records Perpetuation Fund (1189) (the fund) for the purpose of preserving records and improving the Recorder's Office record-keeping systems and equipment.
2. The current revenue to the fund is sufficient to fulfill the statutory purpose of the fund for calendar year 2025;
3. The technology of the County Recorder's office is presently updated and at a level to sufficiently meet the statutory purposes of the fund and the County Recorder's office;
4. The fund has a sufficient reserve, consistent with the Recorder's plan to capitalize the next technology or other records management upgrade necessary to fulfill the statutory purpose of the fund and the County Recorder's office;
5. The County Recorder specifically requests that a specific, identifiable portion of the Recorder's Records Perpetuation Fund (1189) be used to pay Office Supplies, and Other Services and Charges in the amount of \$5,025.
